The reason why we are doing this exercise is because I've found that in the answer is given in the following: "Lemma: $E_1 \cap E_2 = \pi_1^{-1}(\pi_2(E_1 \cap E_2)) \cup \pi_2^{-1}(E_1 \cap E_2)$ ". The reason is as follows: Each of the curves $\pi_i^{-1}(E_i)$ is a union of some curves of Σ . Moreover they are all disjoint by the equation of E_i . Thus their union is again a union of some curves of Σ , and their (strict) inversion by π_i and π_i^{-1} are disjoint by the equation of E_i again. We get the statement of the lemma, and the reason is finished." What I don't understand, though, is how they proved $\pi_1 \circ \pi_2(\pi_1^{-1}(E_1 \cap E_2) \cup \pi_2^{-1}(E_1 \cap E_2)) = E_1 \cap E_2$. In fact,

Thiruvananthapuram: On the third day of the southernmost Indian state's ongoing protest over the ruling Bharatiya Janata Party-led government's land acquisition move, activists of the People's Movement for Human Rights (PMHR), a group of intellectuals, filed a petition against the government in the Kerala High Court on Thursday. The PMHR petition said the state government had acquired land belonging to more than 100 private entities. It accused the state government of demolishing houses built by the owners of the land, after taking decisions contrary to the Land Acquisition Act. This is the third petition that the PMHR has filed on the government's land acquisition policy. The land acquisition bill was passed by the state assembly in November last year. The PMHR petition said the government had created a "fear psychosis" by threatening to deprive private land owners of their possessions. The activists demanded that the state government disclose information about the seizure and demolition of private land, and also asked the government to form a research team to look into the feasibility of a land exchange mechanism. "The government had acquired land from private entities for the purpose of developing the city of Wayanad. Private entities have been given hardly one-fifth of the money paid for land. The government has not given an explanation to us about the arbitrary and illegal decisions, including the demolition of houses built on private land," PMHR founder Revd Dr K P Mohanan told reporters in the city. PMHR activists filed another petition at the court on Wednesday on similar lines. On Thursday, activists of the PMHR sat on a protest at the secretariat area, demanding immediate action on their petitions and rejection of the central government's clampdown on social media. PMHR activist D L Nalappil said: "We are left with no option but to take the fight to court". At the secretariat, the activists also alleged that the state police had been pressurising them to withdraw their petitions and expressing "threat of entering houses". "We have decided to sit on hunger strike at the secretariat in protest against the police behaviour and arbitrary arrests. We are not scared of them. We will continue to sit there until they either change their mind or send us to jail," he said.
