Then they must file a claim if the claim is under \$50,000 to receive workers' compensation. The most common claims in

workers' compensation cases involve injuries such as back injuries, injuries to the head, neck and shoulders, and injuries to the arms and hands. Many of the injuries require surgery or other medical treatment. These claims can take a long time to settle and typically require the injured party to submit to a medical examination and see a personal injury lawyer. Workers' compensation cases are typically not litigated in court. Thus, they do not involve jury trials or the high stakes usually associated with a claim. Worker's compensation cases are instead handled by an insurance adjuster. The adjuster will review and analyze the facts of the case, communicate with the insurance company and the injured party, and then draft a settlement proposal. These procedures usually take between 1 and 2 months. During this time, the parties negotiate the amount to be paid for the injuries sustained. Once the adjuster has produced a settlement proposal
